

TERMS OF USE FOR THE WEBSITE

www.eastwind.ai

1. GENERAL PROVISIONS

- 1.1. These Terms of Use for the website www.eastwind.ai (hereinafter referred to as the "Terms") govern the relationship between Joint Stock Company Eastwind (hereinafter referred to as the "Company") and users of the website www.eastwind.ai (hereinafter referred to as the "Website") regarding the procedure for using the Website, the information and materials posted on it.
- 1.2. The Website is owned by the Company and is managed by the Company.
- 1.3. These Terms constitute a legally binding agreement between the Company and the user, defining the rules for using the Website.
- 1.4. If the user disagrees with these Terms (in whole or in part), the user has no right to use the Website and must immediately cease using it.
- 1.5. Use of the Website signifies the user's unconditional and complete agreement with these Terms.

2. TERMS AND DEFINITIONS

- 2.1. The following terms are used in these Terms:
 - 2.1.1. "Website" – a collection of web pages united by a common theme, design and a single address space of the domain name www.eastwind.ai, including all subdomains.
 - 2.1.2. "Company" – Joint Stock Company Eastwind (JSC Eastwind), TIN 6662090423, which is the owner and administrator of the Website.
 - 2.1.3. "User" – any individual or legal entity accessing and using the Website.
 - 2.1.4. "Website Materials" or "Content" – all information posted on the Website, including, but not limited to: texts, articles, descriptions of products and services, graphic images, photographs, illustrations, video materials, audio materials, program code, scripts, design, structure and layout of the Website, trademarks, logos, databases and other intellectual property objects.
 - 2.1.5. "Personal Data" – any information relating to a directly or indirectly identified or identifiable individual (personal data subject).

3. PERSONAL DATA

- 3.1. The issues of processing users' personal data are governed by a separate document – the Personal Data Processing Policy of JSC Eastwind, which is posted on the Website.
- 3.2. By using the Website and providing their personal data through forms on the Website, the user confirms that:
 - 3.2.1. They have reviewed the Personal Data Processing Policy;
 - 3.2.2. They agree with the terms of personal data processing set forth in the Policy;
 - 3.2.3. They give consent to the processing of their personal data in accordance with the Policy.

- 3.3. In case of disagreement with the Personal Data Processing Policy, the user must refrain from providing their personal data through the Website.

4. INTELLECTUAL PROPERTY

- 4.1. Exclusive rights to the Website as a whole and to all Website Materials belong to the Company or third parties who have granted the Company the relevant rights.
- 4.2. All Website Materials are intellectual property objects and are protected by the legislation of the Russian Federation on intellectual property, including copyright law, trademark legislation and other laws.
- 4.3. The following designations are trademarks (service marks), exclusive rights to which belong to the Company:
- Eastwind (word designation)
 - Eastwind logo (graphic image)
- 4.4. Use of the Company's trademarks and other designations (including logos, corporate symbols, corporate colors) by third parties is permitted only with the Company's prior written consent.
- 4.5. Any third-party trademarks mentioned or depicted on the Website are the property of their respective owners and are used by the Company solely for the purpose of identifying and describing the relevant products and services.
- 4.6. Providing access to the Website does not imply granting the user any rights to Website Materials or the Company's intellectual property objects.

5. RULES FOR USING WEBSITE MATERIALS

- 5.1. The Company grants users a limited, non-exclusive, non-transferable right to view and use Website Materials for personal non-commercial purposes, subject to compliance with these Terms and the legislation of the Russian Federation.
- 5.2. The user has the right to:
- 5.2.1. View Website Materials using a web browser;
 - 5.2.2. Save individual Website pages on their device for personal non-commercial use, provided that all copyright information is retained;
 - 5.2.3. Quote Website Materials to the extent justified by the purpose of citation, with mandatory indication of the source in accordance with Article 1274 of the Civil Code of the Russian Federation;
 - 5.2.4. Place links to the Website on social networks and other websites, subject to compliance with the rules of Section 8;
 - 5.2.5. Use Materials for educational and scientific purposes with indication of the source.
- 5.3. The user has no right to
- Make any changes to materials, use them for commercial purposes of any kind, publicly display them, sell them;
 - Subject software to decompilation, except in cases and strictly within the limits provided by applicable law;
 - Remove from materials any copyright notices and other proprietary rights notices;
 - Transfer materials to third parties.
- 5.4. Any use of Materials not provided for by these Terms requires the Company's prior written consent.

- 5.5. To obtain permission, it is necessary to send a request to: info@eastwind.ru specifying: which materials are intended to be used, for what purposes, and contact information.

6. LINKS TO THIRD-PARTY RESOURCES

- 6.1. The Website may contain links to websites, services or resources of third parties ("Third-Party Resources") that are not owned or controlled by the Company.
- 6.2. Links to Third-Party Resources are provided solely for the convenience of users and do not imply approval, support or recommendation by the Company of such resources.
- 6.3. When following a link to a Third-Party Resource, the user leaves the Website. The Company does not control and is not responsible for:
- 6.3.1. The content, accuracy, privacy policy, terms of use of Third-Party Resources;
 - 6.3.2. Goods, services or information offered on Third-Party Resources;
 - 6.3.3. Any damage that may arise as a result of using Third-Party Resources.
- 6.4. The user uses Third-Party Resources at their own risk and bears full responsibility for compliance with the terms of use of such resources.

7. RULES FOR PLACING LINKS TO THE WEBSITE

- 7.1. Any links to the Website may only be made with the consent of the Company, except for links on search servers, provided that the following rules are observed:
- 7.1.1. Link without the right to reproduce information. Any reproduction of information from the Website is possible only with the written consent of the Company. It is prohibited to create the impression that the Company supports the website owner or approves of their products.
 - 7.1.2. It is prohibited to provide false information about the Company's services and software products.
 - 7.1.3. The Company's logo (trademark) must be presented without distortions and/or changes.
 - 7.1.4. It is prohibited to place information that may be considered unpleasant, offensive, controversial or contains age restrictions.
 - 7.1.5. The Company may, at any time and at its discretion, prohibit the creation of links (or a specific link) to its Website.
